To our valued customers;

We wish to formally advise you that Robert Bosch Tool Corporation intends to initiate a voluntary public recall in cooperation with the U.S. Consumer Product Safety Commission (CPSC) and Health Canada for the above referenced product.

Bosch Tool has determined that under heavy loading conditions the tool can overheat. The Product may present the risk of personal injury or property damage due to this condition. Bosch Tool discovered this issue through its quality control and safety monitoring procedures and to date, there are no reports of injury or property damage due this condition.

We ask that you immediately stop sale of the affected product, utilize the included RGA paperwork to return all on hand inventory to the location provided below. Please contact your Account Representative if you have further questions. All restocking fees will be waived as we proactively work through this process. The RGA paperwork will provide specific instructions for returning the product. The suggested replacement for 1380SLIM is the 1375A. Your Account Representative, or Bosch Customer Service will provide set up data, including price and availability, on this and other potential solutions for your customers.
