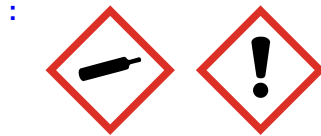

Section 5. Fire-fighting measures

Extinguishing media

- Appropriate engineering controls** : Good general ventilation should be sufficient to control worker exposure to airborne contaminants.
